THREE YEAR OLDS Nominations close Sunday, March 19, for a fee of \$500. Any horse that has won a graded stake or has participated in a race at Gulfstream Park will be charged no additional fees to enter and start. Any horse that has finished second, third, or fourth in a graded stake shall pay a fee of \$2,500 to enter and start. All other horses shall pay a fee of \$5,000 to enter and start. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: 122 lbs. Starters to be named through the entry box by the usual time of closing. Supplemental nominations may be made at time of entry for a fee of \$1,500, which does not include the entry or starting fees as stated above. All fees shall be paid prior to the start of the race. All horses that are nominated or supplemented to the Xpressbet Florida Derby may be subject to out of competition testing prior to the running of the race. If more than 14 horses are entered, preference will be given to graded stakes winners, then by highest career earnings.
