**FOUR YEAR OLDS AND UPWARD** Free nomination by Sunday, February 19. \$1,500 to enter and \$500 to start. \$200,000 Guaranteed. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. Weight: 123 lbs. Non-winners of a graded stakes at nine furlongs or over on turf since September 1 allowed 2 lbs.; a stakes race on turf since September 1, 4 lbs.; three races other than maiden, claiming, or starter, 6 lbs. Starters to be named through the entry box by the usual time of closing. Supplemental nominations may be made at the time of entry. All fees shall be paid prior to the start of the race. This race will be limited to 14 starters, with also eligibles. If more than 14 horses are entered, preference will be given to graded stakes winners, then by highest career earnings. In the event this race is taken off the turf, it will be run at the distance of one and one-quarter miles and may be subject to downgrading upon review of the Graded Stakes Committee.
