FILLIES AND MARES, THREE YEARS OLD AND UPWARD Free nomination by Sunday, December 17. \$750 to enter. \$100,000 Guaranteed. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: 123 lbs. Non-winners of a graded stakes at nine furlongs or over on turf since June 1 allowed 2 lbs.; a stakes race at nine furlongs or over since June 1, 4 lbs.; three races other than maiden, claiming, or starter, 6 lbs. Starters to be named through the entry box by the usual time of closing. Supplemental nominations may be made at time of entry. All fees shall be paid prior to the start of the race. This race will be limited to 14 starters, with also eligibles. If more than 14 horses are entered, preference will be given to graded stakes winners, then by highest career earnings. In the event this race is taken off the turf, it will be run at the distance of One and One-Quarter Miles. Trophy to the winning owner.
