FOUR YEAR OLDS AND UPWARD Free nomination by Sunday, March 16. \$1,500 to enter. A supplemental nomination fee of \$150 may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. *(FTBOA offers up to \$15,000 to the owners of Registered Florida-breds, divided \$8,000 to the winner, \$5,000 to second, \$2,000 to third). Weight: 124 lbs. Non-winners of a graded stakes at a mile or over since September 1 allowed 2 lbs.; Graded stakes placed since then or non-winners of a non-restricted stakes race at a mile or over since August 1, 4 lbs.; three races other than maiden, claiming, starter or state-bred allowance, 6 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to graded stakes winners 2024-25, graded stakes-placed 2024-25, non-restricted stakes winners 2024-25, then by highest career earnings. Trophy to the winning owner.
