FOUR YEAR OLDS AND UPWARD Free nomination by Sunday, February 16. \$2,000 to enter. A supplemental nomination fee of \$200 may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. (FTBOA offers \$15,000 to the owners of a registered Florida-bred divided \$8,000 to the winner, \$5,000 to second, \$2,000 to third). Weight: 124 lbs. Non-winners of a graded stakes at nine furlongs or over on turf since August 1 allowed 2 lbs.; a stakes race at nine furlongs or over on turf since May 1, 4 lbs.; three races other than maiden, claiming, starter or State-Bred allowance, 6 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to graded stakes winners in 2024-25, graded stakes placed in 2024-25 then by highest career earnings. In the event this race is taken off turf, it will be run on Tapeta at about One and One-Half Miles and may be subject to downgrading upon review of the Graded Stakes Committee.
