FILLIES AND MARES, FOUR YEARS OLD AND UPWARD Free nomination by Sunday, January 12. \$2,000 to enter. A supplemental fee of \$200 may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. *(FTBOA offers \$15,000 to the owners of a registered Florida-bred divided \$8,000 to the winner, \$5,000 to second, \$2,000 to third). Weight: 123 lbs. Non-winners of a graded stakes since July 1 allowed 3 lbs.; Graded stakes placed since then or non-winners of an open stakes race in 2024-25, 5 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to graded stakes winners in 2023-25, graded stakes placed since then, then by highest career earnings. Trophy to the winning owner.
