FILLIES AND MARES, FOUR YEARS OLD AND UPWARD By invitation only, with no fees to enter or start. After payment of 1% to all owners of horses finishing sixth through tenth with up to \$50,000 in additional incentives, the remaining purse will be divided 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth, with 2% donated to Thoroughbred Aftercare. Weight: 123 lbs. Non-winners of a Grade One stakes at a mile or over on turf since July 1 allowed 3 lbs.; Grade 1 placed at a mile or over on the turf since then or non-winners of a graded stakes at a mile or over in 2024-25, 5 lbs. Entries close at noon on Sunday, January 19. The Pegasus World Cup Selection Committee will publish a list of invitees on Wednesday, January 1, with additional lists to follow on Wednesday, January 8, and Wednesday, January 15. A list of reserve invitees, in alphabetical order, may be included with each invitational list. Horses that have been invited to the Pegasus World Cup must confirm intent to run by 10:00am Sunday following the publication of each invitational list. In the event a horse declines invitation, a horse on the reserve list may be invited to the race. The Pegasus World Cup Selection Committee reserves the right to invite a horse not on current reserve list over horses on reserve list. All horses that are invited to participate in the Pegasus World Cup Invitational may be subject to out of competition testing prior to the running of the race. Trophy to the winning owner. In the event this race is taken off turf, it may be subject to downgrading upon review by the Graded Stakes Committee.
