HIWU's partner labs test for Capsaicin Post-Race, Vets List, and Post-Work Samples. Horsemen should read all labels to check for capsaicin in the list of ingredients and exercise caution when using these products close to a race or workout. ATTENTION HORSEMEN:

The aftercare of horses that have shipped to Puerto Rico to race, and are no longer racing, are of great concern to Gulfstream Park and 1/ST Racing. Trainers and Owners are warned not to ship injured or infirmed horses to Puerto Rico or they may be subject to fines and loss of stalls at all 1/ST Racing facilities. We will continue to monitor the number of horses shipped to Puerto Rico from trainers and owners who have horses at Gulfstream Park. Supplements have been cited as a possible source of the banned substance diisopropylamine, though Gulfstream Park notes that no specific products or individual manufacturers have been identified. For a list of banned substances please go to the HIWU website.
