THREE YEAR OLDS AND UPWARD Free nomination by Sunday, December 8. \$1,250 to enter. A supplemental nomination fee of \$100 may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. *(FTBOA offers \$15,000 to the owners of a registered Florida-bred divided \$8,000 to the winner, \$5,000 to second, \$2,000 to third). Weight: Three Year Olds: 123 lbs. Older: 125 lbs. Non-winners of a non-restricted stake in 2024 allowed 3 lbs.; Graded stakes placed in 2024 or non-winners of three races other than maiden, claiming, starter or State-Bred allowance, 5 lbs. All fees shall be paid prior to the start of the race. Preference will be given to stakes winners in 2024, non-restricted stakes placed in 2023-24, then by highest earnings in 2024. Trophy to the winning owner.
