After payment of 1% to all owners of horses finishing sixth through last, 62% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. (FTBOA offers \$15,000 to the owners of a registered Florida-bred divided \$8,000 to the winner, \$5,000 to second, \$2,000 to third). Weight: 123 lbs. Non-winners of a graded stakes at a mile or over allowed 2 lbs.; a stakes race or a race at a mile or over other than maiden, claiming, starter or State-Bred allowance, 4lbs. Starters to be named by usual time of classing. All force placed then the start of the race. Profesorous will be given to graded stakes winners, stakes placed then by highest except carriers. closing. All fees shall be paid prior to the start of the race. Preference will be given to graded stakes winners, stakes placed then by highest career earnings.
