**FILLIES AND MARES, FOUR YEARS OLD AND UPWARD** Free nomination by Sunday, January 28. \$1,250 to enter. A supplemental nomination fee of \$100 may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. \*(FTBOA offers \$15,000 to the owners of a registered Florida-bred divided \$8,000 to the winner, \$5,000 to second, \$2,000 to third). Weight: 123 lbs. Non-winners of a graded stakes since July 1 allowed 3 lbs.; a stakes race since April 1, or three races other than maiden, claiming, starter or state bred allowance, 5 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to stakes winners in 2024-25, stakes placed in 2024-25, then by highest career earnings. Trophy to the winning owner.
