FILLIES AND MARES, THREE YEARS OLD AND UPWARD Nominations close Sunday, December 8. \$1,500 to enter. A supplemental nomination fee of \$150 may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. *(FTBOA offers \$15,000 to the owners of a registered Florida-bred divided \$8,000 to the winner, \$5,000 to second, \$2,000 to third). Weight: Three Year Olds 122 lbs, Older: 125 lbs. Non-winners of a graded Stakes on turf since May 1 allowed 2 lbs; a graded stakes in 2024 or a non-restricted stakes race on turf since June 1, 4 lbs. Preference will be given to graded stakes winners in 2023-24, graded stakes placed in 2023-24, non-restricted stakes winners in 2024 then by highest earnings in 2024. In the event of this is taken off the turf, it may be subject to downgrading upon review of the Graded Stakes Committee. Trophy to the Winning Owner.
