FOUR YEAR OLDS AND UPWARD Free nomination by Sunday, March 16. \$2,000 to enter. A supplemental nomination fee of \$200 may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. *(FTBOA offers up to \$15,000 to the owners of Registered Florida-breds, divided \$8,000 to the winner, \$5,000 to second, \$2,000 to third). Weight: 124 lbs. Non-winners of a graded stakes at nine furlongs or over on turf since September 1 allowed 2 lbs.; a stakes race at nine furlongs or over on turf since August 1, 4 lbs.; three races other than maiden, claiming, starter or state-bred allowance, 6 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to graded stakes winners in 2024-25, graded stakes-placed in 2024-25, non-restricted stakes winners 2024-25, then by highest career earnings. In the event this race is taken off the turf, it will be run at the distance of about one and one-half miles on Tapeta course and may be subject to downgrading upon review of the Graded Stakes Committee. Trophy to the winning owner.
