

## 3rd Running Of The Royal Palm Juvenile \$100,000

## (Plus \$25,000 Travel Stipend)

TWO YEAR OLDS Free nomination by Sunday, April 27. \$1,000 to enter. A \$100 supplemental nomination fee may be made at time of entry. After payment of 1% to all owners of horses finishing seventh through last, 50% of the remaining purse shall be paid to the owner of the winner, 22% to second, 12% to third, 8% to fourth, 5% to fifth and 3% to sixth. \*(Winner will receive a \$25,000 equine travel stipend from the United States to England and an automatic entry into one of the Royal Ascot's six two-year-old stakes races). Weight: 121 lbs. Maidens allowed 3 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to stakes placed, then to winners of non-claiming races, then to horses that have finished second in maiden allowance races, then to highest earners (earnings under \$1,000 not considered in preferences). If race overfills trainers will be limited to two entrants in body of race. In the event this race is taken off turf it will be run on the Tapeta course at the same distance.
