FILLIES AND MARES, THREE YEARS OLD AND UPWARD Free nomination by Sunday, December 8. \$1,250 to enter. A supplemental nomination fee of \$100 may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. \*(FTBOA offers \$15,000 to the owners of a registered Florida-bred divided \$8,000 to the winner, \$5,000 to second, \$2,000 to third). Weight: Three Year Olds: 123 lbs. Older: 125 lbs. Non-winners of a graded stakes since May 1 allowed 3 lbs.; a graded stakes in 2024 or a non-restricted stakes race since June 1, 2024, 5 lbs. Preference will be given to graded stakes winners in 2023-24, graded stakes placed in 2023-24, non-restricted stakes winners in 2024 then by highest earnings in 2023-24. Trophy to the winning owner.
