Attention Trainers: In accordance with Gulfstream Park and Broward County Environmental Protection Agency all hoses without nozzles will be removed. Please move all Washing Machines onto Wash Pads or they will be removed.

For Lasix amounts other than 5 CCs, please contact Lasix Coordinator Nancy Triola 24 hours prior to race day at 410.920.5038.

Any Covered Horse that has not raced for 150 or more days, the trainer or trainer's designee shall complete a Layoff Report and submit it to HISA. Trainers are responsible for completing the Post Layoff Report in the HISA Portal PRIOR to entry. Please allow 10-14 days for the form to be processed and approved by a Regulatory Veterinarian. Trainers will be notified through HISA when a horse has been off for 140 days.

Trainers stabled at Gulfstream Park or Palm Meadows that plan to ship for a race out of town MUST first speak with Mike Costanzo or Mike Lakow.

Please make all entries before a final is called and regardless of race count. A race has a better chance to go, to be worked on, or to be brought back as an extra, if you ENTER the race.

Submit race requests to racerequest@gulfstreampark.com. Be sure to include all essential information for any request, such as horse name, surface, distance etc.

Attention Trainers: Trainers wishing to saddle on the horse path or at the end of the saddling area must wait until all horses have been scanned and have entered the saddling area.

All horses entered must have Gulfstream Park as the Certificate Manager on Worker's Comp. policy.

ATTENTION TRAINERS: If a trainer enters both Turf and Tapeta in the same race totaling more than two, the Tapeta Only will not be permitted to run on the Turf regardless of scratches.

ATTENTION TRAINERS: Once a horse works for the Regulatory Veterinarian to come off of the Vet's List, it must race within 60 days of removal from the Vet's List, or it will be placed back on the Vet's List.

Attention Horsemen: Prior to shipping horses into Gulfstream Park trainers must contact Ed Coletti: 352-817-3366. Palm Meadows, Grae Kennedy: 502-457-3323.

ATTENTION HORSEMEN: Please check licenses for you and your owners. Please do not go online to renew your licenses. If your owners have a horse in - and will not be here in person to renew their license, trainers take out a temporary license for them.

Attention Horsemen: Remember you must register your two-year olds with HISA, upon arrival on the grounds.

ATTENTION TRAINERS: Tapeta Shoe Rule is the same as the Turf Shoe Rule. NO Traction Devices. Queen's XTs and similar shoes will not be permitted on Tapeta or Turf.

ATTENTION TRAINERS: Capsaicin is used in many peppers including chili peppers, cayenne peppers, and paprika. It is used in pastes, hot sauce, and some pain relief creams, ointments, liniments, braces, and patches. HISA lists capsaicin as a Class B Controlled Substance. HIWU's partner labs test for Capsaicin Post-Race, Vets List, and Post-Work Samples. Horsemen should read all labels to check for capsaicin in the list of ingredients and exercise caution when using these products close to a race or workout. Horsemen or veterinarians with questions may reach out to sciencesupport@hiwu.org.

ATTENTION HORSEMEN:
The aftercare of horses that have shipped to Puerto Rico to race, and are no longer racing, are of great concern to Gulfstream Park and 1/ST Racing. Trainers and Owners are warned not to ship injured or infirmed horses to Puerto Rico or they may be subject to fines and loss of stalls at all 1/ST Racing facilities. We will continue to monitor the number of horses shipped to Puerto Rico from trainers and owners who have horses at Gulfstream Park. We encourage our horsemen to utilize the on-site Safety Steward, Richard Simmons for specific information by calling 754-236-4790 and our on-site Aftercare Coordinator, Raina Gunderson by calling 954-682-1294.

Children under 16 years of age are not allowed in the Receiving Barn.

Attention Trainers: Prior to administering any supplements to any horse, please research the product and check the ingredients, to prevent violations of the possession or use of banned substances. Supplements have been cited as a possible source of the banned substance diisopropylamine, though Gulfstream Park notes that no specific products or individual manufacturers have been identified. For a list of banned substances please go to the HIWU website.

Please Note: Those enrolling in the ACH Electronic Payment Program will be receiving a one-time verification call from Gulfstream Park.

TRAINERS:
Please take time to review new soundness/fitness forms available in racing office at Gulfstream Park and the manager's office at Palm Meadows. You and your veterinarian are required to sign and return these forms in order for your horses to race and have published workouts. A form may also be sent via email, upon request.

House Rule Changes:
1- Entries: Trainers will be limited to TWO entrants per race.
2- Claiming: A trainer must be allotted a stall and have a horse stabled at Palm Meadows or Gulfstream Park AND must have started a horse at Gulfstream Park within 45 days of Claim Date.

IMPORTANT SHIPPING AND STABLING UPDATES ON HEALTH CERTIFICATES AND VACCINATIONS.

All Health Certificates must be dated within five days of arrival.
Requirements for Entry to Gulfstream Park and Palm Meadows.
ALL HORSES entering the grounds must meet the following requirements for shipping.
1. A valid health certificate (CVI) dated within 5 days of arrival at GSP or PM (this time may be shortened in the event of a disease outbreak).
2. A current negative Coggins within 365 days (preferably within the calendar year).
3. Horses shipping in from TAMPA BAY DOWNS are required to have the following vaccines on the Health Certificate:
Flu/Rhino vaccine must be current (within the last 6 months) and must be given at least 14 Days prior to the arrival date.
4. All horses shipping in from ANYWHERE ELSE are required to have the following vaccines on the Health Certificate:
Flu/Rhino must be current (within the last 6 months) and must be given at least 14 Days prior to the arrival date.
Eastern/Western Encephalomyelitis/West Nile/Tetanus Toxoid/Rabies must be administered once within 365 days.
*All Health Certificates are required to have the manufacturer and lot number for the required vaccines written on the health certificate.

ENTRIES/SCRATCHES

Once a final has been announced, additional entries in overfilled races will have the least preference.

It is the Trainer's responsibility to have ownership (bills of sale and trainer transfers) up to date. Any questions contact Mary Donato @ 954-457-6320. When an Owner or Trainer enters two horses in the same race and scratches one leaving a small field, the Trainer may be subject to fines up to \$500.

If a horse is scratched due to a licensing issue the owner and trainer are subject to a fine at the discretion of the Stewards.

Equipment changes are due at the time of entry. Changes are allowed with the permission of the Stewards before the program goes final. Changes after the program goes final will result in a fine. No changes are accepted on race day.
