FOUR YEAR OLDS AND UPWARD By invitation only, with no fees to enter or start first a payment of \$25,000 to owners of Grade 1 and Grade 2 stakes winners in 2024-25 that finish sixth through tenth, \$15,000 to graded stakes-placed horses in 2024-25 that finish sixth through tenth, and up to \$75,000 in additional incentives, the remaining purse will be divided 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth, and 2% donated to Thoroughbred Affercare. Weight: 123 lbs.; Southern Hemisphere Three Year Olds, 117 lbs. Fillies and Mares allowed 5 lbs. Entries close at noon on Sunday, January 19. The Pegasus World Cup Selection Committee will publish a list of invitees on Wednesday, January 1, with additional lists to follow on Wednesday, January 8, and Wednesday, January 15. A list of reserve invitees, in alphabetical order, may be included with each invitational list. Horses that have been invited to the Pegasus World Cup must confirm intent to run by 10:00am Sunday following the publication of each invitational list. In the event a horse declines invitation, a horse on the reserve list may be invited to the race. The Pegasus World Cup Invitational may be subject to out of competition testing prior to the running of the race. Trophy to the winning owner. In the event this race is taken off turf, it may be subject to downgrading upon review by the Graded Stakes Committee.
