After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. *(FTBOA offers up to \$50,000 to the owners of Registered Florida-breds, divided \$30,000 to the winner, \$15,000 to second, \$5,000 to third PLUS \$50,000 for eligible FSS owners divided \$30,000 to the winner, \$15,000 to second, \$5,000 to third). Weight: 122 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to graded stakes winners, graded stakes-placed, non-restricted stakes winners, stakes placed then by highest career earnings. Trophy to the winning owner.
