Trainers will be notified through HISA when a horse has been off for 140 days.

Please take time to review new soundness/fitness forms available in racing office at Gulfstream Park and the manager's office at Palm Meadows. You and your veterinarian are required to sign and return these forms in order for your horses to race and have published workouts. A form may also be sent via email, upon request.

House Rule Changes: 1- Entries: Trainers will be limited to TWO entrants per race.

2- Claiming: A trainer must be allotted a stall and have a horse stabled at Palm Meadows or Gulfstream Park AND must have started a horse at Gulfstream Park within 45 days of Claim Date.

IMPORTANT SHIPPING AND STABLING UPDATES ON HEALTH CERTIFICATES AND VACCINATIONS.

All Health Certificates must be dated within five days of arrival.

Requirements for Entry to Gulfstream Park and Palm Meadows.
ALL HORSES entering the grounds must meet the following requirements for

shipping.

1. A valid health certificate (CVI) dated within 5 days of arrival at GSP or PM (this

time may be shortened in the event of a disease outbreak) 2. A current negative Coggins within 365 days (preferably within the calendar

3. Horses shipping in from TAMPA BAY DOWNS are required to have the following vaccines on the Health Certificate: Flu/Rhino vaccine must be current (within the last 6 months) and must be given at

least 14 Days prior to the arrival date.
4. All horses shipping in from ANYWHERE ELSE are required to have the following vaccines on the Health Certificate:

Flu/Rhino must be current (within the last 6 months) and must be given at least 14

Days prior to the arrival date. Eastern/Western Encephalomyelitis/West Nile/Tetanus Toxoid/Rabies must be

administered once within 365 days.

*All Health Certificates are required to have the manufacturer and lot number for the required vaccines written on the health certificate.

ENTRIES/SCRATCHES

Once a final has been announced, additional entries in overfilled races will have the least preference.

It is the Trainer's responsibility to have ownership (bills of sale and trainer transfers) up to date. Any questions contact Mary Donato @ 954-457-6320. When an Owner or Trainer enters two horses in the same race and scratches one leaving a small field, the Trainer may be subject to fines up to \$500.

If a horse is scratched due to a licensing issue the owner and trainer are subject to a fine at the discretion of the Stewards.

Equipment changes are due at the time of entry. Changes are allowed with the permission of the Stewards before the program goes final. Changes after the program goes final will result in a fine. No changes are accepted on race day.
